Subject: Amendment in guidelines dated 09.01.2017 on Bulk sale of City Compost by Compost marketing companies to farmers under the policy on promotion of City Compost reg.

In order to increase volume of sale of City Compost and to make the compost available at affordable price to farmers, in addition to the existing marketing arrangement, the Fertilizer Marketing Companies registered with the Department are allowed to sell bulk City Compost to farmers under the policy on promotion of City Compost and claim MDA. As per clause 22 (c) of FCO, 1985, for bulk sale of City Compost, Fertilizers marketing companies have to apply to the Government for issuing notification in this behalf. Accordingly, those fertiliser Companies who are interested to market City Compost in bulk are required to apply to Department under **Proforma-1**.

- 2. The terms and conditions for claiming MDA for bulk sale of City Compost to farmers by Compost marketing companies will be applicable with the following amendments in the guidelines for bulk sale of City Compost by Compost manufacturers of dated 09.01.2017 (copy enclosed):
 - i. Fertilisers Marketing Companies like Compost manufacturers as marketers are also allowed to market City Compost in bulk and claim MDA.
 - ii. Page No. 1 of 14, para A. (ii), (iii) & (iv) may be treated as deleted for Fertiliser Marketing Companies only and not for Compost Manufacturers.
 - iii. Under para 6 (page no. 6 of 14), Compost manufacturers as marketer and Fertilisers Marketing Companies can claim MDA directly i.e. the requirement of MDA through Municipality is deleted. Para A(i) will be restricted only to MDA for

sale of City Compost by the concerned Municipality where it is the manufacturer and Marketer.

- iv. Other contents of the O.M. will remain unchanged.
- 3. This issues with the approval of competent authority.
